

Bruce S. Sobel, as Trustee of the Fiber One Trust dated March 9, 2000 ("Fiber One") and on behalf of Bruce Sobel and Debbie Sobel, husband and wife (collectively, "Sobel"), hereby withdraws their Response to the Omnibus Objection to Claims and Motion to Expunge, Reduce or Reclassify Such Claims (the "Objection"), which was filed by Kevin T. O'Halloran (the "Liquidating Trustee") as Trustee of the ML Liquidating Trust ("Liquidating Trust") with respect to the claims filed by Fiber One and Sobel in connection with the above captioned Chapter 11 Bankruptcy Case. Fiber One and Sobel on the one hand and the Liquidating Trustee on the other hand, have agreed that Claim Numbers 1357 and 1708 filed by Fiber One, each in the amount of \$280,958, are duplicative and that Claim Number 1708 should be expunged; and that Claim Number 1357 should survive, together with Claim Number 1570 in the amount of \$618,557.47 which was filed by Sobel.

For the foregoing reasons, Claimants, Fiber One and Sobel respectfully withdraw their Response filed on November 12, 2009 at 1:34 p.m.
