28 Having reviewed and considered the "*ML Liquidating Trust's Omnibus Objection To Claims*
29 *And Motion To Expunge, Reduce or Reclassify Such Claims*" filed on October 13, 2009 ("**Omnibus**
30 **Objection**") [Docket No. 2306], as amended by the "*First Amendment To The ML Liquidating*
31 *Trust's Omnibus Objection To Claims And Motion To Expunge, Reduce or Reclassify Such Claims*"
32 filed on November 6, 2009 ("**First Amendment**") [Docket No. 2375]; and having further reviewed
33 and considered the "*Notice To Claimants Listed On Exhibit E To ML Liquidating Trust's Omnibus*
34 *Objection To Claims And Motion To Expunge, Reduce Or Reclassify Such Claims And Notice Of Bar*
35 *Date To Respond To Omnibus Objection*", ("**Notice of Bar Date**"), filed with the Court and served by

1 U.S. Mail upon all Claimants listed on Exhibit E to the Omnibus Objection and electronically served
2 upon all parties in interest listed on the Court's ECF System on November 2, 2009 [Docket No.
3 2359]; and having further reviewed and considered the "*Certificate Of Service And No Response As*
4 *To Claimants Listed On Exhibit E To ML Liquidating Trust's Omnibus Objection To Claims And*
5 *Motion To Expunge, Reduce Or Reclassify Such Claims and Notice of Lodging Order To Disallow*
6 *and Expunge Duplicate Claims And Reclassify And Reduce Certain Claims of Claimants Listed On*
7 *Exhibit E To Omnibus Objection*" filed on March 29, 2011 [Docket No. 3127]; and having found that
8 proper notice of the Omnibus Objection was given; and having further found that no objections to the
9 Omnibus Objection were timely filed and served by any of the Claimants listed on Exhibit E to the
10 Omnibus Objection (attached as Exhibit "1" hereto); and good cause appearing therefore:

11 **IT IS HEREBY ORDERED** granting ML Liquidating Trust's Omnibus Objection to Claims
12 as it relates to the Claims listed on Exhibit E to the Omnibus Objection (Exhibit "1" hereto).

13 **IT IS FURTHER ORDERED** that the Claims listed in the column entitled "Non-Surviving
14 Claim No." on Exhibit E to the Omnibus Objection (Exhibit "1" hereto) are hereby disallowed in their
15 entirety for all purposes and expunged.

16 **IT IS FURTHER ORDERED** that the ML Liquidating Trust's objection to the amount of
17 Claim No. 1382 – Gerald Gross, Trustee of the Gerald Gross Family Trust dated June 28, 1979, shall
18 be withdrawn and such Claim is therefore allowed in the amount of \$530,046.44.

19 **IT IS FURTHER ORDERED** that the remaining Claims listed in the column entitled
20 "Surviving Claim" on Exhibit E to the Omnibus Objection (Exhibit "1" hereto) shall be allowed in
21 the amount reflected in the column entitled "Allowed Claim."
