

upon all parties in interest listed on the Court's ECF System on October 30, 2009 [Docket No. 2350]; and having further reviewed and considered the "Certificate Of Service And Summary of Responses As To Claimants Listed On Exhibit A To ML Liquidating Trust's Omnibus Objection To Claims And Motion To Expunge, Reduce Or Reclassify Such Claims" filed on March 4, 2011; and having found that proper notice of the Omnibus Objection was given; and having found that the four (4) Responses that were timely filed and served have been mutually resolved; and having further found that no other Responses to the Omnibus Objection were timely filed and served by any of the Claimants listed on Exhibit A to the Omnibus Objection (attached as Exhibit "1" hereto); and good cause appearing therefore:

IT IS HEREBY ORDERED granting ML Liquidating Trust's Omnibus Objection to Claims as it relates to the Claims listed on <u>Exhibit A</u> to the Omnibus Objection (Exhibit "1" hereto).

IT IS FURTHER ORDERED that the Response jointly filed on November 9, 2009 by Jeffrey S. Kaufman and Donna I. Kaufman, Trustees of the Kaufman Family Living Trust and Jeffrey S. Kaufman challenging the objection to Claims #612, #559 and #560 [Docket No. 2380] is hereby deemed withdrawn by mutual agreement of the Claimants and Liquidating Trustee.

IT IS FURTHER ORDERED that the Response filed on November 17, 2009 by Kay A. Kuntz, Trustee of the Kuntz Family Trust challenging the objection to Claims #78 [Docket No. 2408] is hereby deemed withdrawn by mutual agreement of the Claimant and Liquidating Trustee.

IT IS FURTHER ORDERED that the Claims listed on Exhibit A to the Omnibus Objection (Exhibit "1" hereto) shall be reclassified as "Unsecured," as such term is defined in the confirmed Plan of Reorganization in this matter.
