The Omnibus Objection, as it relates to the Claims of 23 Claimants listed on Exhibit H, requests that the Court reduce the amount of certain Claims.² 24 25 All capitalized terms not defined herein shall have the meaning ascribed to them in the Omnibus Objection. ² On November 6, 2009, the Liquidating Trustee filed the "First Amendment To The ML Liquidating Trust's 26 Omnibus Objection To Claims And Motion To Expunge, Reduce or Reclassify Such Claims" ("First Amendment") [Docket No. 2375] to correct nine (9) Claims relating to Exhibits I and J. Because the First 27 Amendment did not affect the Claims listed on Exhibit H, notice of the First Amendment was not mailed to the individual Claimants listed on Exhibit H.

On November 3, 2009, the Liquidating Trustee filed that certain "Notice To Claimants Listed On Exhibit H To ML Liquidating Trust's Omnibus Objection To Claims and Motion To Expunge, Reduce Or Reclassify Such Claims and Notice Of Bar Date To Respond To Omnibus Objection" ("Notice of Bar Date") [Docket No. 2363], and served copies of the Notice of Bar Date and the Omnibus Objection by US Mail, in accordance with applicable Bankruptcy Rules, to all Claimants listed on Exhibit H to the Omnibus Objection and electronically upon all parties in interest listed on the Court's ECF system. That certain "Affidavit Of Service Of Notice To Claimants Listed on Exhibit H To ML Liquidating Trust's Omnibus Objection To Claims And Motion To Expunge, Reduce or Reclassify Such Claims and Notice Of Bar Date To Respond To Omnibus Objection" was filed with the Court on November 20, 2009 [Docket No. 2427].
- 3. As set forth in the Notice of Bar Date, any Claimant wishing to object to the Omnibus Objection was advised that it was required to file a Response, in writing, with the United States Bankruptcy Court for the District of Arizona, 230 N. First Avenue, Phoenix, Arizona 85003, and serve a copy of the Response on counsel for the ML Liquidating Trust, within 15 days from the date of service of the Notice of Bar Date. Claimants were further advised in the Notice of Bar Date that if they failed to file and serve a Response within the response deadline, that the Court may grant the relief requested in the Omnibus Objection without further notice or hearing.
- 4. Based on the November 3, 2009 service date of the Notice of Bar Date, Responses to the Omnibus Objection were required to be filed and served by November 19, 2009.
- 5. Only one (1) Response was filed and served on or before November 19, 2009 in connection with the Claims listed on Exhibit H to the Omnibus Objection. Such Response was filed by Lazarus & Associates, PC on November 18, 2009 [De 2411] requesting an evidentiary hearing on the objection to its Claim #664. As a result of further review and analysis of Debtor's books and records, and supplementary documentation provided by Lazarus & Associates, PC in support of its proof of claim filed in these proceedings, the Liquidating Trust hereby withdraws its objection to the amount of Claim #664 filed by Lazarus & Associates, PC.

- As of the date of filing this Certificate, with the exception of the one (1) Response 6. described in Paragraph 5 above, no other Responses as to Claims listed on Exhibit H to the Omnibus Objection have been received by the Liquidating Trustee, or its counsel, or filed with the Court based on the undersigned's review of the docket in the above-captioned case.
- 7. In addition, as a result of further review and analysis of Debtor's books and records and proofs of claims filed in these proceedings, the Liquidating Trust hereby withdraws its objection to the amount of Claim #185 filed by Gust Rosenfeld PLC.
- 8. Also as a result of further review and analysis of Debtor's books and records, and additional documentation provided by Abacus Project Management in support of its proofs of claims filed in these proceedings, the Liquidating Trust hereby withdraws its objection to the amount of Claim #58 filed by Abacus Project Management. Further, by email dated November 24, 2009, a copy of which is attached hereto as Exhibit 1, Abacus Project Management has confirmed that Claim #136 is a duplicate filing of Claim #58. Consequently, Claim #136 will be disallowed in its entirety and expunged.
- Additionally, Arizona Bank & Trust filed Claim #97, which, for all intents and 9. purposes, combined both a secured and unsecured claim held by Arizona Bank & Trust, both of which claims were specifically provided for in the Confirmed Plan of Reorganization. Subsequent to filing the Omnibus Objection, Arizona Bank & Trust accepted a Deed in Lieu of Foreclosure from the Liquidating Trust in full satisfaction of the secured claim held by Arizona Bank & Trust. As a result, Arizona Bank & Trust's allowed Secured Claim in Class 5 as provided for in Paragraph O of the Order Confirming Investors Committee's First Amended Plan of Reorganization Dated March 12, 2009 [DE 1755], ("Plan Confirmation Order"), has been satisfied in full, and the only remaining claim held by Arizona Bank & Trust is its Unsecured Class 11A Claim, in the amount of \$2,010,652.78, as specifically provided for in Paragraph O of the Plan Confirmation Order. Consequently, Arizona Bank & Trust has authorized the Liquidating Trust to amend Claim #97 to reflect only the amount of the allowed Unsecured Class 11A Claim in the amount of \$2,010,652.78 as set forth in Paragraph O of the Plan Confirmation Order.
